SUBJ : SHY-M Approval of Foreign CAMOs

Memorandum on Continuing Airworthiness Management of Turkish Registered Aircraft (Rev.00)

Continuing airworthiness of Turkish registered aircraft shall be ensured in accordance with the provisions of the regulation SHY-M. Accordingly, for the aircrafts which are in the scope of SHY-M, operators and/or owners of those aircrafts shall have an approval in accordance with SHY-M Subpart 7 that is equivalent to EASA Part-M Subpart G to manage airworthiness of those aircrafts.

In this regard, organizations having capability and/or EASA Part-M Subpart G approval from an EASA member state to manage airworthiness of aircrafts in accordance with EASA Part-M could apply Turkish Directorate General of Civil Aviation to get an approval in accordance with SHY-M Subpart 7 to manage airworthiness of Turkish Registered Aircrafts.

Any organisation requesting Turkish DGCA (SHGM) approval shall apply with the following attachments:

- 1) Filled and signed SHY Form 2M (see Attachment-1).
- 2) Copy of the EASA Part-M and other Approval Certificate(s) (if available).
- 3) Full set of the Company CAME and associated procedures/lists/forms/documents approved by the EU member state NAA/EASA or draft versions of these documents if such approval not exist. CAME shall be developed in accordance with SHT-M/EASA Part-M M.A.704.
- 4) A manpower plan showing that the organisation has sufficient staff to plan, perform, supervise, inspect and quality monitor the organisation in accordance with the scope of work.
- 5) Copy of the reports of the audits performed by the competent authority during the last surveillance period of the EASA Part-M approval and corrective actions details accordingly (if applicable).
- 6) Quality audit plan, list of auditors, quality audit reports and corrective actions details for the last 12 months.
- 7) Bank receipt confirming the payment of the approval fee according to the attached Turkish DGCA charges tariff. (see Attachment-2).
- 8) A supplement to EU member state NAA or EASA approved CAME, which specifies the differences between EASA Part-M and SHY-M activities such as scope of approval,

applicability etc. including a specific commitment to the Turkish DGCA signed by the accountable manager confirming below (if such approval not exist, the mentioned commitment is still required):

- CAME approved by the EU member state NAA or EASA and any associated referenced manuals defining the organisation and procedures upon which SHY-M approval is based as required by SHY-M.
- CAME procedures must be complied with at all time and when work/orders are being progressed under the terms of the SHY-M approval.
- It is accepted that CAME procedures do not override the necessity of complying with any new or amended regulations published by EASA/Turkish DGCA from time to time where these new or amended regulations are in conflict with these procedures.
- It is understood that Turkish DGCA will approve this organisation whilst the DGCA is satisfied that the procedures are being followed and work standards maintained. It is further understood that Turkish DGCA reserves the right to suspend, limit or revoke the SHY-M approval of the organisation if the DGCA has evidence that procedures are not followed or standards not upheld.
- Access to organisation will be granted to the Turkish DGCA in terms of conduct audit to determine continued compliance with SHY-M approval.
- SHY-M approval will not be used beyond the limitations and Turkish DGCA will be informed as soon as possible, if the EASA Part-M approval is suspended, revoked or limited.

Notes:

- i. On-site audit will be performed to the organisation, if deemed necessary.
- ii. The locations where the organisation intends to manage Turkish registered aircraft shall be covered by the approval.
- iii. Nominated postholders holding Form 4 under EASA Part-M approval will be accepted as nominated postholders for SHY-M approval. However, an interview may be done, if deemed necessary. Otherwise, applications for Form 4 Nominated postholders shall be submitted to Turkish DGCA.
- iv. SHY-M, which is technically identical to EASA Part-M AMC & GMs. Thus, there is no need to make additional evaluation and preparation for the compliance of technical requirements.
- v. Any non-compliance being determined during Turkish DGCA audits or any other channels may be submitted to relevant NAA of the organization and/or EASA (if applicable).
